- jetBlue will start service at SFO on May 3, 2007
- A slight increase in traffic is expected over the summer with the addition of jetBlue, Southwest Airlines, and Virgin America Airlines
- On May 11, 2007 the Airport will know the exact date that Southwest Airlines will begin service at SFO but staff anticipates August or September
- The synthetic radar portion of the noise monitoring system upgrade has been pulled due to escalating costs and uncertainty in the market
- The SOIA / PRM Approach to Runways 28 was used once over the last month
- Noise Abatement staff recently participated in the Boeing Tailored Arrivals Symposium
- Noise Abatement staff has been meeting with Quantas Airlines and Cathay Pacific Airlines regarding their Fly Quiet departure scores
- Additional reports produced by the SFO Noise Abatement Office are now available on its website

# 5. Consideration / Approval of a Draft Letter to Patty Daniel, Support Manager, FAA Northern California TRACON for her assistance to the Roundtable, regarding Aircraft Crossing Altitudes at the Woodside VOR (OSI)

- The Woodside VOR Subcommittee received good cooperation from Patty Daniel and the FAA
- The standard referenced in paragraph three (3) of the letter indicates that the arrivals over the Woodside VOR are within the 7,700 to 8,300 foot range when in fact the standard isn't 7,700 to 8,300 but 8,000 +/- 300 feet
- The +/- 300 feet represents the margin of error in the data readout in each aircraft transponder
- The following amendment to the Patty Daniel letter was requested:
  - First sentence of paragraph three (3) to read: The data provided by the SFO Noise Abatement Office Staff has illustrated the crossing altitude of the vast majority of the SFO oceanic jet arrivals over the Woodside VOR (OSI) are at 8,000 +/- 300 feet.

# 8. Tailored Arrivals Update - Boeing Tailored Arrivals Symposium

\*Comments / Concerns / Questions:

- Noise Abatement staff recently participated in the Boeing Tailored Arrivals Symposium held in Seattle. Washington
- The Tailored Arrival Approach originated in Australia
- Sydney and Melbourne Airports were the first to begin using the Tailored Arrival Approach
- Currently, the Netherlands and SFO are also participating in the test of the Tailored Arrival Approach
- At the Boeing Symposium, several airlines expressed interest in trying Tailored Arrivals
- Tailored Arrivals offer three benefits to the airlines: 1) reduced fuel flow 2) better on time arrival performance and 3) reduced emissions and noise reduction
- The use of Tailored Arrivals can reduce noise impacts communities 10 15 miles from the airport, from 3 to 6 decibels
- Tailored Arrivals can be implemented without the need for a large investment or government mandates
- The Tailored Arrival Approach at SFO is still in the testing phase
- Implementation of the Tailored Arrival Approach at SFO will not be feasible within the next 3 5
  years
