Comments / Concerns / Questions:

- RMS #7 is located on a piece of property in which the property owner is requesting more compensation or rent from the Airport in exchange for the monitor to remain on his property
- The noise monitor located in the City of Brisbane (#7) has not been calibrated recently due to the fact that the monitor had been deemed abandoned approximately two years ago (2003)
- Noise monitor #7 has been reliable in the past, it is still reporting quality data and it is being included in the reports generated by the Noise Office
- The equipment located in Brisbane is old and with the upgrade of the entire noise monitoring system, a new location for RMS #7 may be considered

5. Monthly Airport Director's Comments - Mike McCarron, Director, Bureau of Community Affairs

Comments / Concerns / Questions

 All three bond rating agencies have changed SFO's financial outlook from negative to stable, specifically citing the Airports ability to control costs and lower Airport and Airline operating costs

- The Noise Office is in the process of updating the Noise Monitoring System, but staff has experienced a
 few setbacks including, problems with the poles the microphones are mounted on, an unproductive
 contractor, and difficulties obtaining permits from various cities.
- Cathay Pacific Airlines is continuing to work with the Noise staff in an attempt to improve their Fly Quiet scores
- SOIA/PRM went into operation at the of October and SFO anticipates seeing the most benefit from SOIA/PRM during the Spring and Summer months
- United has reported an increase of approximately 6% in their on-time performance when using SOIA/PRM

6. Presentation of the 2004 Jon C. Long Fly Quiet Program Awards

- a. Most Improved Airline Award Air France
- b. Best Overall Airline "Quietest Flyer" Award Horizon Air
- c. Chairperson's Award United Airlines

Comments / Concerns / Questions

- Vast improvements in Air France's fleet quality afforded them an improvement of more than 2.25 points
- The fleet quality changes made by Air France included substitution of A-340 and B-777 on over half the routes previously flown with B-747 aircraft
- The three main regional jet operators(Horizon Air, Skywest and American Eagle) all finished within 0.5 points of each other
- Horizon Air won the Best Overall Airline Award with at total score of 9.60
- Cathay Pacific, Gemini Air and United Airlines were all nominated for the Chairman's Award
- United Airlines' dedication to the SOIA/PRM project is what won them the Chairman's Award for 2003-2004
- This is the third year in a row that United has won the Chairman's Award

7. <u>Discussion of Woodside Oceanic Arrivals - OSI Crossing Altitude</u>

- a. Review/discussion of a November 24, 2004 Letter From the Hon. Stephen Toben, Council Member, Town of Portola Valley, to Various Council Members in Four Southern San Mateo County Cities (Atherton, Menlo Park, Redwood City and Woodside), re: Noise Abatement Procedures for Oceanic Arrivals in the Vicinity of Skyline Blvd. / Highway 35
- b. Presentation by Patty Daniel, Air Traffic Support Manager, Northern California TRACON, RE: Air Traffic Procedures for Oceanic Arrivals in the Vicinity of Skyline Blvd. / Highway 35

Comments / Concerns / Questions

- The mission of the FAA in regards to air traffic control is the safe and efficient movement of air traffic
- Noise abatement is the third concern of controllers, only after the safe and efficient movement of air traffic
- Not every air traffic controller or every pilot does their job in the same way
- A recent change that removes the nighttime restriction on arrivals coming in over Woodside from the ocean will hopefully improve the aircraft noise in the area
- At times, to the public it might look like there are no visual conflicts between aircraft over Woodside, but the reason it looks like that is because the controllers are doing their jobs
- When the sky isn't too busy it is easy to get aircraft across Woodside at 8,000 feet

- It is particularly difficult to get Oakland traffic across Woodside at 8,000 feet because Oakland traffic has to get under SFO traffic with 1,000 foot separation
- NORCAL TRACON recently completed a briefing of all controllers specifically on noise abatement procedures
- A huge improvement has been made in that traffic use to cross Woodside regularly at altitudes around 6,000 feet
- On average 100% of aircraft crossing over Woodside are at 7,400 feet
- The 8,000 foot crossing at Woodside is not a "hard floor", and it only becomes a consideration when "traffic is permitting"


