- Song will be undergoing a name change only
- Song service at SFO will now be conducted under the "Delta" name

- PARTNER has 12 active research projects, 8 noise and 4 emissions

- On October 12th the Woodside VOR Subcommittee visited Northern California TRACON
- Oceanic Arrivals are defined as traffic inbound over the ocean from the west (flights inbound from Hawaii)
- Point Reyes and Big Sir arrivals are not encompassed within "Oceanic Arrivals"
- Aircraft are brought in over the ocean holding an altitude, the aircraft then begin a descent once past the Woodside VOR
- NORCAL TRACON controllers are given noise abatement training
- NASA is currently exploring specialized approaches
- Next Woodside VOR Subcommittee Meeting will be on December 13th
- A public workshop regarding the Woodside VOR will be held in Portola Valley in January
