### 4. Monthly Airport Director's Comments

Comments / Concerns / Questions

- Air traffic remains consistent with small decrease in domestic traffic and a small increase in international traffic
- Higher ticket prices and fuel prices across the country are the reason traffic remains stagnate
- Average fares are up 10%
- The Noise Office Staff has been working with the FAA on the Oceanic Tailored Arrivals over Woodside and should be testing the approach soon
- The Noise Office Staff is working on the relocation of the noise monitor (#13) in the Town of Hillsborough

### 6. Work Program Items 2005 - 2006

### a. Jon C. Long Fly Quiet Program Report Second Quarter 2006

#### Comments/Questions/Concerns:

- Fly Quiet numbers dropped during the second quarter 2006 due to the runway resurfacing project
- The overall score average was 6.26 down 0.06 from last quarter
- The Fleet Quality average dropped 0.20 due to increase in cargo activity
- The increase in Gap Departures due to the runway resurfacing project caused the Noise Exceedance average to drop 0.40 to 8.09
- The Nighttime Runway Use average went from 6.89 to 4.06
- The Shoreline Departure average dropped 0.30
- The Gap Departure average was down 0.04
- The Fly Quiet information and quarterly reports are published in English and disseminated to all the Airlines using SFO
- English is the international language of aviation and all pilots are required to speak and understand English

## b. Review / Discussion of the Jon C. Long Fly Quiet Program Criteria and Reporting for Aircraft Arrivals

#### Comments/Questions/Concerns:

- The Fly Quiet Program currently only rates procedures that the pilots have control over
- A new Fly Quiet category that rates aircraft arrivals over the Foster City area was researched by the SFO Noise Office
- The Foster City Arrival category uses a rating system similar to the Fly Quiet Shoreline Departure rating
- Only jet arrivals landing on Runways 28 L/R between 11:00 p.m. and 6:00 a.m. are graded
- As arriving aircraft that crosses over or flies through set "gates" established by the Noise Office Staff are rated as "Good", "Marginal", or "Poor"
- Any aircraft crossing through multiple gates will be graded based upon the score of the lowest of all the gates crossed
- The Foster City arrivals will be graded quarterly
- This item will be brought back to the Roundtable at the next meeting for formal approval

## c. Consideration / Approval of Re-establishing a Roundtable Media Program and Appointment of a Roundtable Media Program Subcommittee

### Comments/Questions/Concerns:

- Website design and function should be considered
- Direct the information to schools
- Utilize cable channel spots
- Publish articles in neighborhood association newsletters and Chamber of Commerce newsletters
