4. Monthly Airport Director's Report

*Comments / Concerns / Questions:

- SFO passenger levels remain approximately 15% below the peak levels experienced in 2000
- SFO is recording record levels of international passenger traffic
- Southwest Airlines will start service on August 26, 2007
- Virgin America Airlines is anticipated to start service within the next few months
- A slight increase in traffic is expected over the summer with the addition of jetBlue, Southwest Airlines, and Virgin America Airlines
- These new Airlines will use new aircraft to serve SFO and therefore the noise impact is expected to be very minimal
- SFO has experienced a fair amount of "west flow" days lately due to wind direction
- Over the last few weeks Runway 1 has been closed during the evening hours for maintenance/construction resulting in Runway 28/28 operations
- Known flight pattern changes are noted on the SFO Noise website

Since using the B-777 as a replacement to the B-747 aircraft, Air New Zealand has improved their Fly Quiet Program score by a total of 3.47 points when compared to last year

Air New Zealand was unable to attend, but issued the following statement: It's nice to see we are doing something that has a positive impact on the environment in regards to noise. It's an honor to receive this award.

- United should also be recognized for its ongoing work with SOIA/PRM and theOceanic Tailored Arrivals

*Comments / Concerns / Questions:

- The overall average score for the 1st Quarter 2007 Fly Quiet Report was 6.69, up 0.2 from last quarter
- Airline Fleet Quality is up from last quarter due to airlines using newer Airbus Aircraft
- The Noise Exceedance rating is up 0.1 from last quarter at 8.5
- The Nighttime Runway Use rating is down 0.9 from last quarter at 4.84
- The drop in Nighttime Runway Use scores were due to runway closures and changes in wind direction
- The Shoreline Departures were up from last quarter at 8.29
- The Gap Departure rating was up from last quarter at 6.10
- The Foster City Arrival rating was at 7.39

6. Informational Item: Oceanic Tailored Arrivals Data Update

*Comments / Concerns / Questions:

- Tailored Arrivals will not require airlines to purchase any additional equipment
- Tailored Arrivals aim at providing a continuous descent from cruise altitude to touchdown
- Tailored Arrivals will allow for both fuel and noise savings
- With Tailored Arrivals, airlines can see a savings of up to 4200 lbs of fuel per flight
- Tailored Arrivals can also reduce the duration of a flight by several minutes
- There are three (3) main projects underway 1) Asia 2) Netherlands 3) United States
- SFO tests were run with a B-777 from Honolulu, Hawaii to San Francisco, CA
- Two (2) periods of data collection were used Aug 06 Sept 06 and Dec 06 Jan 07
- Regular or 24/7 Tailored Arrivals are not anticipated to begin at SFO for at least another two years
- Low congestion (midnight 6am) Tailored Arrivals may start much sooner
- Low congestion Tailored Arrivals would effect approximately 7-8 flights
