4. Monthly Airport Director's Report

Comments / Concerns / Questions:

- SFO experienced a 15% drop in international passenger traffic in November
- The numbers for domestic passenger traffic in November are not in yet but a decline of approximately 4-5% is anticipated
- A 5.5% reduction in flights for the fiscal year ending June 30, 2009 is expected
- Step one, a communications waiver, was granted by the FAA in a two step process to certify SOIA PRM to be used when the cloud cover at SFO is at 1600 feet
- Once certified at the lower cloud cover level, aircraft will be able to use SOIA PRM to simultaneously land on both runways instead of only using one runway at a time
- SFO, American Airlines, and the FAA are working on NextGen technology and are looking at starting a pilot program at SFO
- It is hoped that the NextGen technology will help reduce delays resulting from low cloud cover and, at the same time, offer a noise benefit by utilizing a gradual descent arrival procedure
- Airline fares are starting to come down and the fuel hedging that Southwest Airlines was experiencing is coming to an end
- Southwest Airlines has announced that it will be cutting back flights in December 2008 and January 2009

6. Review / Approval of a Revised Roundtable Logo and a New Roundtable Tag Line

Luca LLC, based in San Francisco, has been retained by the County of San Mateo to assist the Roundtable in reactivating the Roundtable Media Program

- The scope of work for the Roundtable Media Program includes developing a new logo and tag line
- The new logo and tag line will be a visual representation of who the Roundtable is and what the Roundtable does
- Once approved, the logo will be used on Roundtable stationary, in the Roundtable electronic newsletter, and on the Roundtable website
- The proposed color for the new Roundtable logo is blue
- Blue was chosen for the following reasons 1) blue has been a primary color used by the Roundtable over the last 25 years, 2) the Roundtable currently utilizes various colors of blue on the website, 3) this particular color blue is very universal and can be printed very inexpensively
- Having the airplane or the home inside the "O" in SFO makes the "SFO" predominate in the logo
- Combining the two tag lines to create "Working together for quieter skies and quieter living" was suggested
- If the purpose of the logo is convey who we are and what we do then we might want to make a connection between the airport and the community
- A concern that the home within the "O" in SFO looks too much like an arrow was made and perhaps updating the home graphic would make the logo not so flat

ACTION: Jim Hartnett MOVED approval of Logo Option Two and Tag Line Option One. The motion was SECONDED by Omar Ahmad and CARRIED, UNANIMOUSLY.

- A misunderstanding of the motion was discussed

ACTION: Ken Ibarra MOVED to rescind the previous action and to approve Logo Option Two with a change to the house graphic within the "O" in "SFO" and Tag Line Option One as is. The motion was SECONDED by Sepi Richardson and CARRIED, UNANIMOUSLY.

 Staff was directed to alter the home graphic within the "O" on logo option two and forward the change on to Ken Ibarra for his approval

7. Roundtable Coordinator (Consultant Contract) Selection Process

a. Roundtable Coordinator (Consultant Contract) Selection Process: Approve Distribution of a Request for Qualifications (RFQ) to an RFQ mailing List

Comments / Concerns / Questions:

 The Roundtable Coordinator consultant will be responsible for the day to day activities of the Roundtable; the scope of work for the consultant will consist of a combination of the scopes of work for the two consultants that are currently assisting the Roundtable (Assistant Roundtable Coordinator and Roundtable Project Manager)

- The level of effort and level of activity of the Roundtable has been reduced over the years
- The Roundtable currently operates on a bi-monthly meeting schedule
- David Carbone has been reclassified to a management level position as a Transportation Systems Coordinator for the County of San Mateo and as a result, his responsibilities will be shifting to focus more time on C/CAG related airport environs planning projects
- This change will result in Dave having less time to devote to the day to day support of Roundtable activities and therefore, the County will need to put out an a Request for Qualifications (RFQ) to hire a consultant to take his place
- David Carbone will remain in an oversight role with the Roundtable but will not function as the Roundtable Coordinator
- Once the RFQ is sent out interested parties, they will have about a month to submit a
 response to the RFQ. The RFQ responses will be evaluated and interviews will be
 scheduled.
- It is estimated that a recommendation to the full Roundtable would be made at the February 2008 meeting
- It was recommended that the proposed funding amount of \$50,000 be increased to a not to exceed amount of \$60,000
- The contract amounts for the two current Roundtable consultants combined are not to exceed \$10,000 and \$40,000
- The Roundtable Coordinator consultant could estimate working approximately 20 hours a week
- It is estimated that the County staff oversight time need for the Roundtable will be about 20% rather than the current 50%

ACTION: Jim Hartnett MOVED approval of the RFQ with an adjusted contract amount not to exceed \$60,000 and the distribution mailing list. The motion was SECONDED by Sepi Richardson and CARRIED, UNANIMOUSLY.

b. Appoint a Roundtable Coordinator Selection Subcommittee to Evaluate Qualified Candidates and Make a Recommendation to the Full Roundtable

Task Force, RE: Preparation of an Update of the Regional Airport System Plan
Analysis (RASPA) Document

- Last year the Roundtable appointed Roundtable Staff (David F. Carbone) to serve on a task force to assist the Regional Airport Planning Committee (RAPC) to update the Regional Airport System Plan Analysis (RASPA) document
- The Task Force met in May and October in 2008
- The RASPA update effort will address specific environmental issues
- Of most interest to the Roundtable will be an analysis of aircraft noise impacts related to various aviation demand scenarios for commercial service airports in the Bay Area
- Part of the RASPA effort will include holding four public workshops in various Bay Area locations to present system scenarios
- The Roundtable may want to consider sponsoring one of the public workshops
- The next Task Force meeting will be held on January 9, 2009
- It is estimated that the RASPA document update will be completed by April 2010
- The Roundtable directed Staff to inform the Task Force that the Roundtable would be interested in sponsoring one of the public workshops

b. Results from the Airport Cooperative Research Program (ACRP) Report: Project No. 02-05, RE: Guidebook on Community Response to Aircraft Noise

Comments / Concerns / Questions:

- The Vision 100- Century of Aviation Reauthorization Act provided new opportunities for aircraft noise impact reduction through funded research
- The research effort is managed through a subsidiary, the Airport Cooperative Research Program (ACRP)
- An oversight committee comprised of industry representatives functions as the governing board for the research program
- ACRP Project No. 02-05, Guidebook on Community Response to Aircraft Noise, was one of the initial research projects to be implemented
- ACRP Project No. 02-05 was initiated to produce a comprehensive guidebook and a set of tools to enable airport decision makers to better manage community expectations related to aircraft noise issues
- The project was scheduled to be completed in October 2008, but most likely the final product will not be released until early 2009

c. Review of Fly Quiet Program Quarterly Report – 3rd Quarter 2008

Comments / Concerns / Questions:

- The Fly Quiet Program Quarterly Report presentation format has been updated by the SFO Noise Abatement Office
- The new presentation format will show Fly Quiet Score trends over time and allow for easier comparison of performance from quarter to quarter
- The overall average Fly Quiet Summary score was down this quarter from 6.38 to 6.10
- Delta and Virgin America have moved into the top five in the Overall Scoring for 3rd
 Quarter 2008
- Cathay Pacific and China Airlines have moved into the bottom five in the Overall Scoring for 3rd Quarter 2008
- The Fleet Noise Quality average score held steady over last quarter at 4.90

- Northwest improved its Fleet Noise Quality Rating this quarter and was in the top 5 in this category
- The average Noise Exceedance score of 8.92 is an improvement 0.5 points over last quarter
- The average Nighttime Preferential Runway Use score declined over last quarter
- The average Shoreline Departure Rating score was down 0.5 points over last quarter at 8.90
- FedEx, Frontier, and Korean Air all improved their Shoreline Departure Rating score over their scores from the previous quarter
- The average Gap Departure Climb Rating was down 1.3 points over last quarter at 4.46
- The average Foster City Arrival Rating score remained level when compared to last quarter at 6.70
