5. Monthly Airport Director's Report

Comments / Concerns / Questions:

- Passenger traffic in December 2008 was up 1.8% over last year
- The growth in passenger traffic is largely due to the increase in the number of flights offered by Virgin America and Southwest Airlines
- The installation of the new noise monitoring system is going well and the new monitors in Hillsborough and Brisbane will be installed very soon
- Meetings were recently held with Mexicana and British Air regarding their Fly Quiet scores
- Follow up phone calls were also made by Noise Abatement Staff to Singapore Airlines, China Airlines, Eva Air, Aer Lingus, Sun Country Airlines, and Southern Air to discuss their Fly Quiet scores
- The purpose of these meetings and phone calls are part of the airport's ongoing efforts to make sure that the pilots understand the procedures they should be using when operating at SFO
- 6. <u>Introduction of Todd Green, Airport Noise & Environmental Specialist at Centennial Airport, Denver Colorado, RE: Consideration of Creating a Public Forum, Similar to the Roundtable, for the Centennial Airport</u>

- Centennial Airport is the second busiest general aviation airport in the country
- During the process of Centennial Airport's Part 150 noise compatibility study the airport was approved to proceed with organizing a noise roundtable
- Centennial Airport chose to visit and observe the SFO Airport/Community Roundtable because of its longevity and success
- During his visit, Mr. Green met with SFO Noise Abatement Staff and Roundtable Staff to get a better understanding of how the Airport and the Roundtable operate

b. Report on the Feasibility of Sitting a Ground Run-up Enclosure (GRE) on the Airport

Comments / Concerns / Questions:

- A Ground Run-Up Enclosure (GRE) is a three-sided enclosure within which an aircraft is parked to perform engine runups (as part of an engine maintenance procedure)
- The exhaust noise from the runup procedure is redirect up into the atmosphere as opposed to being directed outward and potentially into communities surrounding the airport
- In 1999 during the Airfield Development Bureau Development Project or Runway in the Bay Project it was thought that space on the airfield might be available to accommodate a GRE
- With the termination of the Runway in the Bay Project the anticipated available land to place the GRE on is no longer available
- Airport Staff has surveyed the airfield and found no existing available land areas sufficient in size to accommodate a GRE
- A ground run-up enclosure requires not only a large amount of space, but it must also be oriented correctly, based on the prevailing wind direction, and must have convenient taxiway access
- Aircraft run-ups are currently performed at designated areas on the airfield and are always performed with aircraft facing into the wind
- The current designated run-up areas attempt to push or direct the noise associated with the run-up out over the Bay whenever possible
- As part of the Phase II Noise Upgrade to the Noise Monitoring system in several of the designated run-up areas the Airport has installed a Ground Run-up Detection System
- The Ground Run-up Detection equipment consists of solar powered noise monitors and video cameras
- The equipment allows the Noise Abatement Office to monitor the aircraft performing engine run-ups and evaluate the noise created from the run-up verses the community noise level

c. Roundtable Fly Quiet Video1. Status Report

Comments / Concerns / Questions:

- The goal of the Fly Quiet Program Video Project is to create a video intended to be used as an educational tool for the airlines operating at San Francisco International Airport to further enhance and promote the Fly Quiet Program
- The video will demonstrate to the airlines how to improve their individual Fly Quiet scores
- The primary audience for the video will be the airline pilots, however the video may also be useful to other noise stakeholder groups
- Roundtable Staff, Noise Abatement Staff and the Fly Quiet Program Video Project Subcommittee have spent many hours brainstorming and planning this project
- A script and production timeline has been created and we are ready to begin filming
- Several Bay Area firms were contacted and asked to submit rough cost estimates for the video project
- Bryan Kingston Media provided the most financially feasible estimate (not to exceed \$15,000)
- The next step in the process will be to establish a contract between San Mateo County and Bryan Kingston Media
- Once the contract process is complete, shooting of the video can begin
