#### c. Presentation of Jon C. Long Fly Quiet Program Awards for 2007-2008

- The "Quietest Flyer" or Best Overall Airline Award is presented to an airline that holds the quietest rating in each Fly Quiet category and for 2007 – 2008 Horizon Airlines had an overall Fly Quiet score of 8.97.
- The Most Improved Airline Award is presented to an airline that has shown the most improvement in each of the six Fly Quiet categories. Over the course of the 2007 2008 rating period Sun County Airlines has made an overall all improvement of 1.5 points.
- The Chairman's Award is presented to an airline in recognition of its exceptional commitment to all aspects of the Fly Quiet Program, its efforts within the industry and in particular, it efforts focused on local communities.
- The Chairman's Award recognizes an airline that goes above and beyond mere
  participation in the program. It is intended to honor an airline that has demonstrated a
  significant effort in working toward reducing the noise impact on the communities
  surrounding SFO.
- Southwest Airlines has quickly become one of SFO's busiest carriers. With an overall score of 8.19, the Southwest Airlines has managed to be near the top of the list in overall scores qualifying Southwest Airlines for the Chairman's Award for 2007 2008.
