# V. Report on the American Association of Airport Executives (AAAE) Airport Noise Mitigation Symposium (ANMS) held in San Francisco in October 2010

SFO's Director of the Bureau of Community Affairs, Mike McCarron, gave a brief report in the AAAE Noise Mitigation Symposium held in San Francisco just before the October Roundtable meeting. Attendance was very good and the Symposium touched on a number of relevant topics.

# VI. Debut of the Roundtable / SFO Fly Quiet Program Video and Approval of Future Distribution and Presentation of the Video to Other Audiences

Roundtable Coordinator, Steve Alverson, gave a brief history of the development of the Fly Quiet Program Video and thanked everyone involved in its development/production. The video was played and received applause/praise from numerous Roundtable members.

Comments/Concerns/Questions: Comments were raised regarding the description in the video of directions relative to SFO, but it was concluded that they were minor in nature and would not affect the actions of the pilots as it relates to adhering to the Fly Quiet Program.

Action: Julian C. L. Chang MOVED the approval of the distribution and presentation of the Fly Quiet Program Video to other audiences including but not limited to Roundtable member organizations, local cable providers, Penn-TV, and other media distribution channels as appropriate. The motion was SECONDED by Christine Krolik and CARRIED, UNANIMOUSLY.

#### VII. FY 2009 – 2010 Roundtable Work Program Items

A. Presentation of a Recommendation from the Strategic Plan Subcommittee, re: Recommended Draft Roundtable Strategic Plan 2011- 2013

Steve Alverson gave a brief overview of the Strategic Plan update process and directed Roundtable Member's attention to the materials provided in the October meeting agenda packet, which provide a comprehensive written overview of the process as well as a copy of the Draft Strategic Plan. Steve suggested that the Roundtable review the Plan before the December 1, 2010 Regular meeting at which the Roundtable will be asked to approve the Plan.

Comments/Concerns/Questions: Chairperson Mark Church indicated that he would have some minor correction of typos for Roundtable Staff, but that the Plan looked very good.

B. Update on NextGen Air Traffic Control Technology: What Does it Mean for SFO?

SFO Noise Abatement Manager, Bert Ganoung, provided an overview of the five elements of the Next Generation (NextGEN) Air Traffic Control System and described how those elements would improve air traffic safety and efficiency in the future throughout the United States and at SFO. Moving away from land-based navigational aids to satellite-based system is central to NextGEN upgrade. The east coast is receiving the initial upgrades with the initial basic installations hitting the West Coast in 2012. The installation is scheduled to be completed nationwide by 2025. SFO will experience the NextGEN upgrade in phases as follows: Multilateration Installation, Runway Entrance Light System, Automatic Dependent Surveillance Broadcast (ADS-B), and Approach and Departure procedures implemented throughout the NextGEN upgrade including Area Navigation procedures (RNAV), Required Navigation Performance (RNP), and ADS-B procedures. Bert concluded his presentation by indicating that NextGEN will reduce gridlock in the air and on the ground throughout the nation, enhance the safety and efficiency of SFO, and result in procedural changes that will make SFO operate more efficiently in both good and poor weather.

Comments/Concerns/Questions: Julian Chang asked if there are redundancies built into the NextGEN system. Bert indicated that there are redundancies in that there are multiple satellites. Rich Newman added that controllers will still be providing clearances and monitoring aircraft movements. Michael Brownrigg asked if NextGEN will help SFO's capacity. Mike McCarron responded that SFO does not have a capacity problem, but SFO would like to have the same level of aircraft throughput regardless of the weather conditions.

### C. Fly Quiet Program Quarterly Report

Bert Ganoung reviewed the Fly Quiet Program results for the Second Quarter 2010. Of note were drops in adherence to the Nighttime Runway Use and Shoreline Departure procedures. The volcano eruption in Iceland affected the timing of some nighttime flights and instrument conditions due to the cool weather both affected the nighttime runway use numbers. Shoreline Departure adherence was affected by instructions that were missing from the departure plates used by some airlines' navigation systems. SFO is working to get this error corrected.

Mark Church reviewed the proposed revised budget that includes a one-time 50 percent reduction in member fees with the exception of fees for the San Francisco Airport Commission.

Comments/Concerns/Questions: Julian Chang asked about the LCD projector in the budget. Steve Alverson responded that the current projector is SFO's and in the future we may use two projectors at a time. Michael Brownrigg asked if the City of Daly City had been informed of the fee reduction. Mark Church indicated that the proposed fee reduction had not yet been passed by the Roundtable, but the City of Daly City would be notified if the proposal passes.

Action: Ken Ibarra MOVED approval of the Proposed Revised Roundtable Budget for FY 2010/2011. The motion was SECONDED by Michael Brownrigg and CARRIED, UNANIMOUSLY.

#### XII. Aviation Noise News Update

Steve Alverson provided a brief update on a few newsworthy items related to aircraft noise, including the continued delay of funding of the FAA Airport Improvement Program (AIP).
