#### FAA Reauthorization Act of 2018

- Study on Potential Health and Economic Impact of Overflights
  - FAA recently awarded MIT and Boston University School of Public Health a \$1.7M grant to conduct the study
  - Study must focus on the following areas: Northern California Metroplex, Southern California Metroplex, New York, Boston, Chicago, District of Columbia, Phoenix and Seattle
- Noise Ombudsmen
  - FAA has elected to designate their community engagement officers as the regional ombudsmen
  - All in the process of being on-boarded and trained
- Study of Alternatives to the DNL Noise Metric
  - Report will be submitted by the end of the year on alternative metrics



#### FAA Reauthorization Act of 2018

- Report on Community Involvement Practices for NextGen Metroplex Projects
  - The report at a minimum must address:
    - How the FAA will improve community involvement practices
    - How and when the FAA will engage airports and communities
    - Lessons learned and how those lessons are being integrated into future community involvement practices



### House Quiet Skies Caucus

- The House QS Caucus has given the FAA Administrator 30 days to answer 45 questions on aircraft noise impacts and related issues
- The 44-member caucus have serious concerns regarding airplane and helicopter noise and the FAA's "lack of responsiveness" to communities impacted by it

### FAA Advisory Circular Updates

- The FAA issued AC 150/5050-4A: Community Involvement on Airport Planning
  - Document describes changes in standards and expectations for community involvement in airport planning since the FAA drafted the previous version in 1975
- The FAA also issued a draft AC 150/5000-9B: Guidelines for Sound Insulation of Structures Exposed to Aircraft Noise
  - This draft to industry provides updates on guidance on developing and managing programs
  - Comments on the draft due by December 6<sup>th</sup>



### FAA Metroplex Project Delays

- According to a Department of Transportation Office of Inspector General report, delays in the FAA Metroplex projects liked caused by increased community concerns about aircraft noise
- FAA has completed 7 of 12 Metroplex projects to date
- The remaining are not expected to be complete until 2021, which is 4 years later than originally planned
- November 18<sup>th</sup> Update:
  - Final EA for the Denver Metroplex has been issued with a 32-day public comment period
  - Draft EA for the Las Vegas Metroplex has been released for public comment



#### Airbus Voom Service

- Airbus-owned Voom launched its first U.S. helicopter service in the Bay Area
- Helicopter flights would operate between SFO and 4 other Bay Area airports
- Pricing at about \$200 per ride for the Palo Alto to SFO route, which would take about 10 minutes



## Integration of Urban Air Mobility (UAM)

- Recently a non-profit association called Community Air Mobility Initiative (CAMI)
  was launched to support integration of UAM into communities through education,
  communication and advocacy
- CAMI members and subject matter experts to work with local municipalities to help establish standards for vertiports, operations, security, etc.
- CAMI members include:
  - Bell, NBAA, SAE International, Raytheon, Massachusetts DOT, etc.
- Currently there are more than 200 eVTOL aircraft concepts being explored around the world; it is important to work with all stakeholders now to develop UAM that integrates with existing transportation systems
