Dear SFO Round Table,

I would like to make a comment on an Item Not On The Agenda for the 1 December 2021 SFO Round Table Meeting, as follows,

As a Brisbane resident, my family and I have been strongly and adversely impacted by the implementation of the NextGen flight procedures. It has been particularly frustrating that SFO noise data and noise studies in Brisbane, including near my home, have not accurately reflected the actual impact on people that the NextGen disturbance has caused. The SFO noise data and studies have significantly and consistently understated that impact.

It is my understanding that SFO will soon transition to the ANEEM method of aircraft noise tracking. It also my understanding that this method more accurately reflects the impact that aircraft noise has on residents on the ground.

I fully support this change at SFO.

However, at the same time and given my past experience with SFO and noise, I have limited trust in SFO to implement the system so that the impact on people is accurately and transparently recorded and reported to the public in a timely manner and on regular basis.

Therefore, I request that all aspects and parameters of the new system be fully presented to the public and vetted in public discussions so that we, and our own experts, can ensure that the new system will meet the public's need for accurate and transparent reporting of aircraft noise as it relates to the impact on people on the ground.

I am writing as a concerned citizen of Brisbane to ask that the new system of reporting airport noise known as the "Aircraft Noise Event Extraction Methodology" ("ANEEM") be formally agendized and open to public discussion by the SFO Airport Community Roundtable ("SFORT") at the next regular meeting and/or as soon as possible. I do not see this item on the agenda at the moment (may have missed it) and am commenting on it within this letter.

A open, and public, discussion of the ANEEM system is critical for the public, as well as SFORT, to understand how the system is to be implemented and to better ensure that data is collected, presented and utilized in a manner which reflects the noise levels experiences by effected citizens. A collaborative process should be encouraged and is absolutely necessary to ensure a relationship of trust with all the parties involved. The ANEEM data will undoubtedly be presented in the Airport Director's Reports. These reports present an account to the public of the Airports operations and their impact on neighboring communities.
