"Up the Hill" Ground Based Noise (GBN) Monitoring

- Five portable noise monitors deployed to support this study in addition to nine permanent sites.
- The data collected is being reviewed for good correlations to aircraft noise events.
- The Noise Office will compile fourteen reports from the data and provide to the Roundtable.







SCI: RECENT PHASES

SCI: ONGOING WORK

- 2022-2026 SCI Phase (FAA AIP-85 Grant):
 - ✓ Total budget: \$3.0 million (SFO Funds: \$600K; FAA Grant: \$2.4 million)
 - ✓ Scope: Potential insulation of 3 homes (acoustical test results pending)
 - ✓ Construction schedule: Apr/2024 to Aug/2025








EEI: CURRENT PHASE

- 2022-2026 EEI Phase (FAA AIP-86 Grant):
 - ✓ Total budget: \$12 million (SFO Funds: \$2.4 million; FAA Grant: \$9.6 million)
 - ✓ Re-insulation of residential properties insulated before 1993
 - ✓ Scope: Replacement insulation of homes in 2 groups
 - ✓ Group 1 includes treatment of 33 homes. Construction Jun/2024 to Dec/2024
 - ✓ Group 2 will potentially involve treatment of up to 54 homes. Construction Jan/2025 to Jul/2025
